

Funding Categories

The Delta Foundation believes that small positive changes can have a much larger impact, especially those made in effort to transform our communities. Our quality of life priorities include those that can not only provide tools and services, but will leave an ever-lasting impact. We encourage all organizations that support these priorities to apply for a grant through the Delta Foundation.

Arts & Education

Programs are established outside of primary or secondary schools and work with the community by providing educational or art-related services. These programs can vary in their target audience and content.

Mental Health & Wellness

Programs that serve the community by providing tools or services that better those with emotional, environmental, financial, social, or physical needs. These programs focus on the overall wellness of their target audience.

Basic Needs

Programs that address the basic needs of the community, including but not limited to: food, shelter, clothing, hygiene, and tools for long term success. These programs can be broad or specific in the services they provide.

Eligibility

Eligible Recipients

- Must be a non-profit organization under section 501(c)3 of the Internal Revenue Code and contributions be deductible under section 170 of the Internal Revenue Code
- Must be a community-based organization operating in areas where CFD employees reside
- Services rendered by the organization (including religious organizations) must be open to all members of the community regardless of race, religious beliefs, political affiliation or background
- Must fit into one of the funding categories listed above

Ineligible Recipients

- Grant recipients within the last 12 months
- Private foundations
- Tax-supported institutions
- Organizations falling under:
 - Individuals or fraternal organizations
 - Social (fraternities, sororities, alumni)
 - Athletic teams or booster clubs
 - Professional associations
 - Scouting associations
 - Political organizations or campaigns
 - Religious organizations without secular community designation

Complete Grant Applications must be:

1. Submitted using the official Delta Foundation Grant Application Form
2. Submitted by the current deadline for the 2024 cycle: **August 31st**
3. Signed by an authorized official of your organization, including board President or Chairperson
